Hospital Meals

For the 13th year, Thursday's Child is funding one meal every month for parents of seriously ill children who are patients at American Family Children's Hospital in Madison. Each evening meal serves 50-60 people. Thursday's Child donates \$3,000 each year to provide these meals. The hospital itself, through money donated by NFL Alumni, funds one meal per week. Other meals come from organizations like ours.

Sandy's Trail Ride



We treasure the Santa Project thank you notes that we receive. Sue Hefty and Steve Maerz, make sure that all families referred to us are sent gift cards from JC Penney: \$50 per child with a \$200 limit per family.

We would like to share this sample of notes selected from our archives:

"We felt a little guilty taking this money knowing that our son was scanned in early December and they said he was in remission, but then we decided that it had been a really tough year for him with radiation, chemo and surgery, so we decided to spoil him and his brother. I'm glad we did. The next morning he woke up with a headache. We spent Christmas morning in ER, getting a CT scan of his head where they found a new tumor."

"We want to thank you from the bottom of our hearts for the generous gift cards. You can be assured that they were put to good use this Christmas. We continue to be astounded at the wonderful care and outreach that we have received from both the UW Children's Hospital and Thursday's Child. We feel like we are not walking this journey alone."

"I am 15 years old. I have been dealing with my illness since I was six years old and have recently felt out of hope but, when my family and I received your letter and its contents it showed us that people do still care and that I'm not alone. My mother is the strongest person I know and when you sent her that letter she wept with tears of joy. You have no idea how it feels to know people still care and haven't given up. Thank you so much for what you have done. You have made this Christmas so special for my family and me."

"Thank you so very much for helping my family make this a great Christmas for my boys. It has been a very difficult seven months for our family. It was truly fantastic to see my son forget about being sick for just a little while. I really can't express enough how grateful I am."

"Thank you for your help with the gift cards. The kids were able to get a whole bunch of new clothes which they needed. Happy Holidays."

"Thank you so much for the generous gift card. Our son was diagnosed with a very rare cancer and we have been through a lot since then. We are only able to get through it with the love and kindness of people such as yourselves. Our son gained a lot of weight during his treatments as a result of the medications. He outgrew most of his clothes and was never well enough to shop for replacements. Finally this Christmas his immune system allowed him to get out and about. We were able to get some new blue jeans for him. Thank you for your kindness."

"....My children (ages 11, 12 and 14) know there is no Santa and they also understand that Christmas this year is more about family and health and what we have that others don't...such as love, friends, a home, food, etc. I went to JC Penny while they were at school purchasing a few select items which they will find under the tree. Because of their ages and different tastes, I then decided to share how I received the gift cards and took them shopping letting them make some choices. We had a marvelous evening. We all ended the evening in high spirits and renewed Christmas spirit. Thank you so much for the priceless shouts of joy I'll treasure as I said "sure" when they showed me something they chose. You have my deepest thanks for allowing us this experience."

"Thank you so much in order for my children to have Christmas."

This year, social workers have referred 194 children to us. Sometimes there are last minute additions, but we always manage to meet our Christmas Eve deadline.

To everyone at Thursday's Child, Culver's and our new friends in Green Bay:

"We don't even know where to begin to thank you. We had such a fantastic time in Green Bay at the Packers game and wow, what a game it was, too. You can't even imagine the smile on our son's face as we walked to our seats and he saw Lambeau Field for the first time on a game day. It has been a very long time since we have seen him so happy and smiling from ear to ear. That smile hardly disappeared all day. Thank you everyone for making this trip possible. We will remember that day forever"
